- I agree to avail services of DigiCable/DigiDPR at prevailing rates from time to time, intimated to me and as per my choice indicated on rate card mentioned with this form duly signed., and also agree to continue availing services by the service provider

 I am aware that, unless specifically agreed otherwise, the Set Top Box and remote hand set shall remain the property of the service provider and hence I am responsible to maintain the same in serviceable condition or shall be liable to pay charges for restoration of serviceability, if any, at any time that the device become un-serviceable

 I also understand that I am liable to pay all applicable taxes / surcharge etc. from time to time, as mentioned in my bill, in addition to charges for the services availed by me and the services can be disconnected on default in remultance of amounts due by due date, which may be re-connected on payment of additional charges by me.

 All disputes concerning this agreement shall fall in the exclusive jurisdiction of courts of law at Mumbai.

SUBSCRIBER'S AGREEMENT

- PART-I: DEFINITION

 (i) "Addressable systems means an electronic device or more than one electronic device put in an integrated system through which television signals can be sent in encrypted or unencrypted form, which can be decoded by the device or devices at the premises of the subscriber within limits of the authorization made, on the choice and request of such subscriber by Digicable/DigiJPR to the subscriber.

- "Broadcaster" means a company from which Digicable/DigiJPR sources its programming services.
 "Cable Operator" means any person / entity, duly authorized by Digicable/DigiJPR, who provides Services through a cable television network after receiving the same from Digicable/DigiJPR.
 "Channels" means and includes such satellite-based free-to-air & pay (encrypted) television/radio channels and other value-added services as may be authorized, which shall be distributed by Digicable/DigiJPR as part of its service.
- Digicable/UgJBFR as part of its service.
 "Pay Channel" means a Channel distributed/retransmitted by Digicable/DigJPR in an encrypted mode and received by the Cable Operator which can be viewed by the Subscriber only by means of the STB.
 "Permitted Viewing Device" or "PVD" means either a viewing device and/or a hearing device which is specifically permitted, being television and personal computer.
 "Programme" means any television broadcast and includesa) exhibition of films, features, dramas, advertisements, serials, news & current affairs;

- b) any audio or visual or audio-visual live performance or presentation and the expression "programming service" shall be construed accordingly;
 "Service" means the services provided by Digicable/DigiJPR and any value added services as may be authorized directly at the Subscriber Premises through the STB, in accordance with the Subscription Peanuet (viii)
- Trogicable/DigiJPR" means Digicable Network (India) Pvt. Ltd/DigiJPR Network (India)Pvt. Ltd.
 "STB" (Set-top-box) means a device, which is connected to a PVD, which is compatible with and is able to receive and/or decode the subscribed Service through an addressable system, regardless of its brand or manufacturer or acquisition source to enable subscriber to view the channels.

 "Subscriber Application Form" or "SAF" means the standard format of subscription application form (SAF) to enable prospective Subscriber to subscribe to the Service by duly filling, signing by accepting the terms & conditions mentioned overleaf to the SAF and submitting it to Digicable/DigiJPR

 "Subscriber Premises" means the installation location specified by the Subscriber in the SAF where the BTB is to be installed to view the Service.

 "Subscribion Request" means the Pay Channel(s) and/or bouquet of Channels and applicable tariff plan/scheme selected by the Subscriber by filling of the requisite Subscription Application Form manually or through any electronic mode or any modification/amendments effected therein from time to time.

 "VC" (Viewing Card) means the smart card approved and duly branded by Digicable/DigiJPR, which when inserted in the STB, enables the STB to decode the Service or portion thereof that the Subscriber has sought under the Subscription Request.

 "Standard Tariff Package (STP)" means a package of tariff as may be determined by TRAI for supply of a STB to the Subscriber by a service provider for receiving programs.

 Programming: All programs under the Service are protected by Indian Copyright laws. The Subscriber cannot \ copy, redistribute or relay or deal with any of the Channels or any part thereof. DigiCable/DigiJPR can replace or withdraw any program or any Channel, or change or reduce the number of hours broadcast for any Channel.

 Personal Information:
 The Subscriber agrees and authorizes DigiCable/DigiJPR to use and disclose the Subscriber's personal information to DigiCable/DigiJPR, its business partners, associate companies, credit reporting

- Personal Information: The Subscriber's agrees and authorizes DigiCable/DigiJPR to use and disclose the Subscriber's personal information to DigiCable/DigiJPR, its business partners, associate companies, credit reporting agencies, credit providers, employers and relevant regulatory authorities in accordance with the applicable Act for the following reasons:
 a) considering or applying DigiCable/DigiJPR credit policy to the Subscriber's application, b) management of the Subscriber's account, including collection of overdue payments, c) maintenance of Subscriber's credit records,

 d) development, research and marketing to the Subscriber and his / her referrals and relations,
 e) billing and collection purposes, and (provision and administration of service. From time to time, DigiCable/DigiJPR may request the Subscriber to review and update the personal information..

 (xviii) Force Majeure: DigiCable/DigiJPR shall not assume responsibility or liability for interruptions or impairment of service due to force majeure and/or circumstances or events beyond its control.

 (xiii) Force Majeure: DigiCable/DigiJPR may change or add terms to this Agreement as it deems reasonable to do so.

 (xviii) Force Majeure: DigiCable/DigiJPR may change or add terms to this Agreement as it deems reasonable to do so.

 (xviii) Termiation: This Agreement will continue unless terminated as per the following events:
 a) The Subscriber may terminate this Agreement at any time after the initial period of five years by giving DigiCable/DigiJPR one calendar month's written notice,
 b) If the Subscriber may terminate this Agreement, DigiCable/DigiJPR may at any time terminate this Agreement by giving one calendar month's notice. There will be no refund on subscription payments or other payments made under this Agreement if DigiCable/DigiJPR may at any time terminate this Agreement by giving one calendar month's notice. There will be no refund on subscription payments or other payments made under this Agreement if DigiCable/DigiJPR hands this Agreement due to Subscriber's violation of the terms of this Agreement In case of termination, the Service will be deactivated and the Subscriber will not be entitled to receive the Service. The Subscriber shall request for re-activation of the Service within 30 days of such termination. Digicable/DigiJPR may consider the request for re-activation at its sole discretion. Re-activation beyond 30 days will entitle DigiCable/DigiJPR has the right to transfer its rights and obligations under this agreement to any company, firm or person. The su

 (xxiv) Serverability: Each provision of this Agreement shall be interpreted in such a manner as to be effective and valid under applicable law, but if any provision of this Agreement shall be held to be valid under applicable law, such provision of this Agreement shall be ineffective to the extent of such invalidating the reminder of such provision of the remaining provision of this Agreement.

 (xxv) Effect of Suspension: if the subscriber's access to the Service is suspended, the subscriber shall continue to be liable for payment of the subscription fee and digicable/DigiJPR shall not reinstated that access

If Digicable/DigiJPR agree to reinstate the subscriber's access to the Service, the fact that such access has been interrupted during the subscription period will not postpone the date on which the subscription period is due to expired.

PART -II: SUBSCRIBERS TERMS & CONDITION

- Agreement commences upon Digicable/DigiJPR installling STB, activating the viewing card (VC) and shall remain in force subject to other terms, as per package (s)/ bouquet (s)/service (s) chosen by the subscriber and operate concurrently with Digicable/s/DigiJPR's permission/license to provide Cable Television Service. Any money paid by the subscriber shall not create any rights in favor of Subscriber until complete verification about subscriber's details & information, is done to the satisfaction of Digicable/DigiJPR In addition, Digicable/DigiJPR reserves right to seek/verify financial and other information from subscriber. On acceptance of the SAF and payment of deposit & rent as per the scheme opted by subscriber, the applicant will become the subscriber of Digicable/DigiJPR for Digicable/SigiJPR's services. Subscriber represents that he/she has been fully informed about the Cable Television Services provided by Digicable/DigiJPR, its specifications, requirements, limitations, etc and has only thereupon opted for such services, filled up and submitted the subscription form, and signed this Agreement.
 Digicable/DigiJPR shall perform its obligations and do inspection under this agreement including collection of subscription charges, deposits, rents, either through its employees or through its authorized cable operator or any other authorized representative

SCHEMES & SERVICES

- The subscriber shall be provided a VC to enable the subscriber to use DigiCable's /DigiJPR's services, which shall be subject to the compliance of the terms & conditions of this agreement, including any modification, alterations, additions, substitution therein, from time to time.

 The VC shall always be the sole property of DigiCable/DigiJPR and shall be returned by subscriber upon termination/determination hereof, and/or deactivation or temporary suspension of services. The subscriber (i)

In es subscriber would be responsible for its safe custody, usage, password and consequence thereof.

 For any change, addition, deletion, substitution, modification of the Service, the Subscriber shall submit the requisite form together with the applicable processing fee/charges at least five (5) days in advance to enable processing of the same and be bound by the additional Terms as may be applicable. Any change or withdrawal from the Subscriber shall not entitle the Subscriber to any refunds or adjustments of the moneys already paid, billed or to be billed under the terms & conditions.

- reasons of up gradation, variations, installation, relocations, repairs, operation and /or maintenance of systems/ equipments/service (d)To combat potential fraud, sabotage, willful destruction etc; (e) For any legitimate business purposes; (d) in compatibility with equipments including set up box, etc; (h)Any delay in nonpayment of any dues, incurring charges in excess of any deposits/ credit limits, non deposit of an increased deposit (s)/advance (s).
 Digicable/DigiJPR is entitled to change, vary, add, withdraw any services/supplementary services/schemes/plans etc. and/ or to vary the charges/ price relating thereto, at any time, in its sole discretion which shall be binding on the subscriber.
 DigiCable/DigiJPR may at any time, through its authorised representatives and/or authorised cable operators, make inspection at the premises of the subscriber with regard to fulfilment of the conditions mentioned in this agreement on the part of subscriber and shall be entitled to take photographs, documents, materials, equipments, etc. so as to prove the violation of this agreement and/or infringement of copyright and trademark of DigiCable/DigiJPR, as detected by finger printing mechanism and/or any other mechanism/ method/ system deployed by DigiCable/DigiJPR in its network for such detection, shall be valid and accentable to the subscriber.
